### Foster Agreement /Understanding

(Also refer to "Standing Rules and Procedures" document)

**FOSTERS WITH RESCUE COMMITMENT:** Foster Homes will be notified prior to receiving an animal if their foster animal already has a rescue commitment. This means that an outside Approved Rescue has made a commitment to this animal. The committed rescue at times may require vetting and other procedures prior to transport. While waiting for transport, the committed rescue will work on locating a foster home or space within their shelter. Once a foster animal has a rescue commitment they cannot be adopted through B.A.R.C. They cannot be networked to other rescues or advertised as a BARC foster animal.

**FOSTERS WITHOUT A RESCUE COMMITMENT:** If a dog is placed in Foster care without a rescue commitment this means they are available to be networked to outside rescues starting immediately. If any Volunteers or members of the community wish to adopt a foster dog they must first notify B.A.R.C. Adoption Coordinator via email or phone and submit their completed Adoption Application and signed Adoption Contract to B.A.R.C. accompanied with the required adoption fee. Once Adoption Application/Contract and fee are received dog will be on hold pending approval of adopter. If a rescue commitment is received prior to the Adoption Application/Contract and Fee than the dog must go to rescue and the adoption fee will be returned.

**CARE OF FOSTER ANIMALS:** *As a foster parent, it is your responsibility for the general care and safety of your foster animal. Foster animals should be kept safe, secure and out of harms way or danger. You will be provided with several names and their contact information in the event there is an emergency with your foster animal or for any questions or concerns you may have. If a medical issue arises, it is the foster parents responsibility to contact the Foster Coordinator or Board Member immediately. In the event of an emergency, foster parent may take the animal to the vet but must call Foster Coordinator or Board Member immediately upon arrival. If expenses for medial procedures or general expenses are incurred without permission from the Foster Coordinator or Board Member than reimbursement will not be available. B.A.R.C. will provide adequate food and approved medical care for your foster animal. Foster animals should be fed a healthy amount of food for their size and weight. If additional expenses, items, special food etc. are required, contact the Foster Coordinator or any Board Member. Foster animals should be treated with kindness and care. Many foster animals were previously abused, neglected or under socialized. If you are unable to care for your foster animal properly or discover he or she may have special needs please contact Foster Coordinator or Board Member immediately.*

As a foster parent(s), by signing below, I (we) agree and understand to the statements above. I (we) further understand that my foster animal is property of B.A.R.C until he or she is legally adopted or released to an outside approved rescue. As a foster parent(s) I have made a commitment to saving the life of an animal and will do everything I can to make my foster animal(s) safe, secure, happy and loved. I understand he or she can be removed from my home at any time.
